

BUT DIDN'T THE WORLD HEALTH ORGANIZATION RECENTLY UPDATE THEIR RECOMMENDATIONS REGARDING MASKS?

WORLD HEALTH ORGANIZATION'S GUIDELINES AS OF JUNE 9, 2020

"The best way to prevent and slow down transmission is be well informed about the COVID-19 virus, the disease it causes and how it spreads. Protect yourself and others from infection by washing your hands or using an alcohol based rub frequently and not touching your face. The COVID-19 virus spreads primarily through droplets of saliva or discharge from the nose when an infected person coughs or sneezes, so it's important that you also practice respiratory etiquette (for example, by coughing into a flexed elbow)."

Wearing a medical mask is one of the prevention measures that can limit the spread of certain respiratory viral diseases, including COVID-19. **However, the use of a mask alone is insufficient to provide an adequate level of protection, and other measures should also be adopted** [emphasis theirs]. Whether or not masks are used, maximum compliance with hand hygiene and other IPC measures is critical to prevent human-to-human transmission."

NO SHOES, NO SHIRT, NO MASK, NO SERVICE?

Some establishments have signs that say, 'No shirt, no shoes, no service'; can they just tack on: 'no mask' to the sign?

"The ADA generally prohibits eligibility/screening criteria that tend to exclude individuals based on a disability, unless the criteria are necessary for the business to operate safely in providing its goods and services.

Those requirements must be based on actual risks and may not be based on speculation, stereotypes, or generalizations about people with disabilities. At this time, businesses concerned about the safety of their staff and customers should be justified in relying upon guidance from the Centers for Disease Control and Prevention (CDC), as well as state and local governments' orders, to justify policies forbidding customers without face masks from entering their stores. However, as guidance and state/local rules change regularly, retailers should regularly track developments so as not to rely on something that is no longer current and applicable.




TITLE II OF THE CIVIL RIGHTS ACT OF 1964: INJUNCTIVE RELIEF AGAINST DISCRIMINATION IN PLACES OF PUBLIC ACCOMMODATION

The Civil Rights Act of 1964 is federal civil rights legislation that prohibits discrimination in numerous settings including: employment, education, voting, and public accommodations. See FindLaw's codes section for the entire Civil Rights Act of 1964. Specifically, Title II prohibits discrimination on the basis of race, color, **religion**, or national origin in places of public accommodations and provides injunctive relief for such violations. See the entire Title II text below.

SEC. 201. (a) All persons shall be entitled to the full and equal enjoyment of the goods, services, facilities, and privileges, advantages, and accommodations of any place of public accommodation, as defined in this section, without discrimination or segregation on the ground of race, color, religion, or national origin.

DECLARATION OF EXCEPTION — **FACE MASK EXEMPTION CARD**

Presentation of this card obliges exemption from public ordinances and recommended health guidelines as wearing a mask poses risk to my health. Under the Americans with Disabilities Act (1990), I am not required to disclose my condition for accommodation to be given. Furthermore, it is illegal for you to ask me about the existence, nature, or severity of a disability. Any attempted questioning in violation to this act, or denial of equal access whether by intimidation or coercion (in violation of the Patriot Act sec. 802) will result in prosecution to the fullest extent of the law including immediate and detailed reporting issued to:

DECLARATION OF EXCEPTION

FACE MASK NON-MEDICAL/RELIGIOUS **EXEMPTION STATEMENT**

Presentation of this card obliges exemption from public ordinances and recommended health guidelines as religious and civil liberties are protected by U.S. Federal Law, Title II & VII of the Civil Rights Act, US Code 42 sec 2000 (a). This law prohibits discrimination in denial of entry, facility use, and reasonable public accommodation on the bases of religious belief. Any attempted denial of equal access whether by intimidation or coercion (in violation of the Patriot Act sec. 802) will result in immediate reporting and prosecution to the fullest extent of the law.

There is no scientific evidence that supports healthy people wearing masks



MEDICAL EXEMPTION SCRIPT

A MESSAGE FOR THE MANAGER TO BE READ OUT LOUD

- 1. A licensed medical professional is the only person qualified to give medical advice, including the advice to wear a mask, which negatively affects the respiratory system, neurological system and immune system.
- 2. Practicing medicine without a license is an offense punishable by law.
- 3. There is no law in this state that requires anyone to wear a mask into any business establishment. Guidelines are not laws.
- 4. Equal access and accommodations in any business establishment whatsoever is protected by law. No citizen may be discriminated against based on a health condition.
- 5. Any threat of intimidation in this matter will result in law enforcement being summoned.



RESPONDING TO CLERKS ASKING YOU TO PUT YOUR MASK ON

- The clerk or manager is not a medical doctor and is not licensed to give medical advice. It is illegal to practice medicine without a license.
- These clerks or managers are not law enforcement and have no legal authority to attempt to enforce law (even those these are not laws). It is illegal to impersonate a law enforcement officer and a police report should be filed.

These clerks and managers are breaking both state and federal non-discrimination laws. Just because a store makes a "policy" does not mean it is legal.

Dear Business Establishment,

Your business has the chance to be a **LEADER** in the retail industry by offering this:

"Special shopping hours for those without a mask."

At the beginning of this situation, many retailers had special shopping hours for seniors and disabled. It's time to PROVIDE THIS RIGHT AWAY:

SPECIAL SHOPPING HOURS FOR THOSE WITHOUT A MASK

Curbside shopping or instacart delivery is not fair and equal access, because there is an additional cost, and shoppers cannot browse and look for new items and experience an enjoyable shopping experience.

Further, this discriminates against those who do not have access to technology. Offering SPECIAL SHOPPING HOURS for those who cannot wear a mask provides for FAIR AND EQUAL ACCESS (as required by state and federal law.)

NOTE: These hours are to be reserved for mask-free shoppers ONLY, so the shopping experience will be relaxing and enjoyable. Those who wear a mask are to shop during the mask hours.

BENEFITS FOR YOUR BUSINESS

- 1. Shoppers who can't wear a mask can shop in comfort and confidence
- free of discrimination, harassment and intimidation.
- 2. Associates will not need to spend time policing mask compliance.
- 3. Further, ASSOCIATES who cannot wear a mask could be assigned to work during those designated hours.
